## MESSAGE FROM THE PRESIDENT

Welcome to the new members and thank you to the existing membership for their continued support and confidence. The present leadership has envisioned bringing a dynamic spirit to APPNA and this year we have embarked on a busy agenda. The salient point of this year is the involvement of the entire executive council and I appreciate the tremendous support that you have all given me. Here are some of the issues;

1. The financial health of the association. The association continues to enjoy a sound financial situation. We are still lagging behind in our fund raising efforts for this year. A number of people are working on it, including the host committee and I encourage each and every one of you to help us with this endeavor.
2. Chicago annual meeting. Please review the report from local host committee chair, Dr. Mushtaq Khan. Dr. Khan and his team have been very busy and have done an excellent job of putting the various pieces together. The theme of the meeting is "APPNA in the New Millennium". Our program will be focused on the new efforts that APPNA plans to undertake for the next several years.
3. APPNA Free Clinics. The need of the hour is to take care of our less fortunate countrymen in this adopted homeland of ours. This country has given us so much, it is time to give back. Several members are working on a framework to provide free or subsidized medical services to the working poor. The concept was presented to the Executive Council at the Washington meeting and fruitful suggestions are being incorporated in the final version.
4. Curriculum update. Most of you are aware of the state of Medical education in Pakistan, both at the undergraduate and post graduate level. The APPNA leadership is working on several fronts to improve the standard of education and training. In the first leg we met with Health Minister of Punjab Government in Lahore last year and at the Washington meeting we had positive discussions with the Principal of King Edward and Allama Iqbal Medical Colleges. We have contacted various local Universities and already have preliminary commitments from Tulane University and Louisiana State University to help us with this endeavor. Chair for the curriculum development, Dr Samadani is working on some solid proposals.
5. APPNA office and membership drive. At the APPNA officers meeting in Chicago, we interviewed various candidates for the job of Executive Director. We are now in the process of signing up a three member group, which includes an Executive Director, a CPA and an Attorney for the overall management of the office. Dr. Zeelaf Munir, Chair of the Membership Committee, already has a lot of bright and excellent ideas. We have had a very good response from the membership drive letter that we sent out in early January.
6. Disaster Relief. This is the most important and often neglected part of our working. This year I have asked Dr Saud Anwar to spearhead the committee. The foremost issues are to layout a plan of action and delineate various levels of resources. We have been asked to help the earth quake victims and organize relief efforts for the Afghan refugees. We hope to work on a new and elaborate plan and be able to provide some assistance.

This agenda is elaborate and needs all the support from our executive council and above all the membership. We cannot do anything without the full support of you *the members* and I thank you again for your participation and continued support.

We all hope that in the future the silent majority shall rise to the podium and demand an end to the personal enmities and restore our faith in the democratic behavior. Above all tolerance for the opposing view and respect for its inherent diversity.

Our words have no respect unless we give respect to the words of others.

### Election for 2002

The Nominations and Election Committee for the year 2001 evaluated the appropriate sections of the constitution; changes adopted by the APPNA Executive Council and presented the following procedure for the election 2002.

1. The elections will be held according to the APPNA constitution and bylaws. (Refer to the section of the constitution and the election policy adopted July 22, 1994.) This year an independent election service organization (Election.Com) will send and receive the ballots. Their representative will bring the votes to the APPNA annual meeting in Chicago.
2. The calls for nominations were mailed and nomination deadline is May 5th, 2001. The last date for new members to be considered for voting is May 15th. The ballots will be mailed on May 31st. Any ballots postmarked after June 22nd, 2001 will not be counted.
3. Each candidate will designate an agent with power of attorney as his or her representative for the counting of votes. Please send a notarized letter to this effect to the Election Committee Chairman by June 15th, 2001.
4. Please send your bio-data and two-passport size photographs for inclusion with the ballots and the election application fee of \$500 to the central office by May 15th, 2001.
5. Please do not contact the election service independently.

Feel free to reach the Election and Nomination Committee for any concern. The committee would like to keep all communications open and proceedings transparent.

## SECRETARY'S REPORT

The APPNA democratic tradition is well, thriving and multiplying this year. The spring meeting in Washington D.C. was remarkable for being tempestuous, cantankerous and contentious. The dinner on Friday was delayed by six finely crafted masterpieces of oratory. And to really confirm the process there are, at this time, two and sometimes even three candidates for every office post on the executive council. The only crack in this seamless paradise of democracy is the lack of nominations for six of the eight Councilors seat. Hopefully this deficiency will be made up next year. As of April 23rd 2001 we have a total of eleven hundred and thirty six members. There are 130 confirmed physicians in training, 423 lifetime members and 583 active members. Most Component Societies have submitted their renewal forms for certification. There are five Societies, which are delinquent. At least half of the Component Societies have not submitted a record of the financial transactions, which include bank statements and cancelled checks. We would appreciate if all of this record would be submitted to the central office before the summer meeting. Failure to send records by June 15th will start the process of de-certification, which will then be presented for approval to the General Body Meeting. Preparations for the summer meeting are proceeding at their usual hectic pace. Dr. Mushtaq Khan and his team are preparing a meticulously planned wonderful long weekend in July. The hotel occupancy rate is at a record time high. Please register early as seating at the Saturday banquet will be done on a first come first registered basis. Hoping to see all of you there.
